FCC NIXES QUES. POOL INCREASE

In April 2008, Michael Mancuso, KI4NGN, of Raleigh, North Carolina, filed a petition with the FCC, seeking to increase the size of the question pools that make up the Amateur Radio licensing exams. Mancuso sought to increase the question pool from 10 times the number of questions on an exam to 50 times more questions. On March 19, 2009, the Commission notified Mancuso that it was denying his petition.

In his 2008 petition, Mancuso claimed that the current question pool is too easy to memorize and "that there has been a significant increase in the number of Amateur Radio operators receiving their licenses over at least the last decade or more who do not appear to possess the knowledge indicated by the class of license that they have received. Most discussion about this topic, both on the air and on Internet forums, generally refers to these widespread observations as the 'dumbing down' of Amateur Radio. It has been widely assumed that the cause of this observed situation is based upon the subject material addressed by the license examinations, that the material requirements specified for the examinations does [sic] not meet some minimum level of knowledge expected by some or many in the Amateur Radio community."

The FCC pointed out to Mancuso that each applicant for a new or upgraded Amateur Radio operator license "is required to pass a written examination in order to prove that he or she possesses the operational and technical qualifications required to perform properly the duties of an amateur service operator licensee, i.e., that he or she is qualified to be an amateur service licensee."

Commission summed up Mancuso's The petition, saying, "You argue that the current question pool size is no longer adequate, because online practice examinations enable examinees to memorize question pool without comprehending the subject matter being tested. Consequently, you propose to increase the size of question pools, in order the to hinder memorization."

The Commission concluded that Mancuso did not present grounds for the Commission to amend its rules: "As noted above, the purpose of the examinations is not to demonstrate an applicant's comprehension of certain material, but rather to determine whether he or she can properly operate an amateur station. Moreover, your contention that there has been 'a significant increase in the number of Amateur Radio operators...who do not appear to possess the knowledge indicated by their class of license' is not supported by any data or facts."

The FCC pointed out to Mancuso that the Commission's Rules only dictate the minimum number of questions for each question pool for the three Amateur Radio license classes. This, the Commission told Mancuso, "does not prevent the National Conference of Volunteer Examiner Coordinators (NCVEC) from increasing the number of questions in a question pool should it decide that this is appropriate. We conclude, therefore, that the petition presents no evidence of an existing problem or other reason for a rule change."

ARRL Chief Executive Officer David Sumner, K1ZZ, said that while he agreed with the Commission's decision, he disagrees with the rationale behind it. "The International Radio Regulations require that administrations verify the operational and technical qualifications licensees, prospective amateur using Recommendation ITU-R M.1544 for guidance," he said. "The present examinations confirm to this requirement."

USCG TO DISCONTINUE LORAN

the US Coast Guard Last month, <http://www.uscg.mil/> announced that due to economic conditions, they would be closing down the 24 LORAN-C (Long Range Aid to Navigation) http://www.navcen.uscg.gov/loran/default.htm stations operated under the auspices of the USCG. LORAN stations provide navigation, location and timing services for both civil and military air, land According to the USCG, and marine users. LORAN-C is approved as an en route supplemental air navigation system for both Instrument Flight Rule (IFR) and Visual Flight Rule (VFR) operations. The LORAN-C system serves the 48 continental states and parts of Alaska.

LORAN-A stations were developed beginning in World War II, and signals were transmitted on frequencies in and around our present-day 160 meter band. LORAN-A was responsible for reduced amateur radio operations, including frequency and power limitations, on 160 meters in the United States. In 1979, the Coast Guard phased out the LORAN-A stations; they were replaced by LORAN-C stations. The newer stations operated on 100 kHz, enabling the restrictions on the 160 meter amateur band due to LORAN functions, to be dropped.

According to the Coast Guard, the nation's oldest continuous sea-going service will continue to operate the current LORAN-C system through the end of fiscal year 2009; it is in the process of preparing detailed plans for implementing the fiscal year 2010 budget. -- Some information provided by Cliff Appel, W7CGA

LABEL CHANGE FOR ARRL MAGS

A change in the postal regulations for flat mail processing takes effect March 29 that will require the addressing area on the front of any flat, bulk-processed mail (such as magazines) be positioned to new specifications. According to ARRL Sales and Marketing Manager Bob Inderbitzen, NQ1R, QST, QEX and NCJ magazines will all have the delivery address imprinted upside down, but positioned in the same area on the front covers.

Some of this equipment has been moved to the Red Cross and we may have to move the rest of it on short notice.

MIDWAY ATOLL TO BE ACTIVATED

Earlier this year, US Fish and Wildlife Service (USFWS) announced that they would open Midway Atoll < http://www.fws.gov/midway/> to Amateur Radio operations for two weeks only, from October 5-19, 2009. Tom Harrell, N4XP, of Monroe, Georgia, and Dave Johnson, WB4JTT, of Aitkin, Minnesota, have put together a team of 19 operators from all over the world to activate Midway Atoll for day period http://www.midway2009.com/>. This the first time that USFWS has allowed amateurs to operate from the wildlife refuge since 2002.

"Midway ranks as Number 24 worldwide and Number 13 in Europe on DX Magazine's Most Wanted List < http://www.dxpub.com/," Harrell and Johnson said. "Activity will be on 6-160 meters with 5 to 6 stations. At least one station will be active on 20 meters around the clock for those who need it for a new country. Major efforts will be made to meet the demand to the most needed geographical areas, the low bands and RTTY." The team has posted a list of planned frequencies on their Web site http://www.midway2009.com/kh4freqs.html>.

The co-leaders said that travel to the atoll is only allowed by chartered aircraft: "Because of the size of the aircraft, the team is presented with unique challenges. As such, the aircraft will only be able to carry the team, requiring the equipment to be shipped by boat some months ahead."

In January, the USFWS started a program to encourage visitors to experience Midway's wildlife, history and culture, as well as non-wildlifedependent activities -- including Amateur Radio. To ensure the safety of the wildlife on the Refuge, Midway Atoll Refuge Manager Matt D. Brown said that Amateur Radio operations will be permitted for two weeks only, and only within a designated area on the north side of Sand Island. Brown also said that while portable generators will not be permitted, there is 120 V power available at the operation site; modifications to the island grid/infrastructure must be approved in advance and be paid for entirely by the radio operators.

Brown said that the K4M team will also be required to attend a refuge orientation shortly after their arrival designed to enhance visitor safety, wildlife protection and overall enjoyment of the wildlife refuge. "Although determined to be a wildlife-compatible activity," Brown said, "this [Amateur Radio] opportunity is being conducted on a trial basis." Brown has the authority to discontinue the activity at any time, based on wildlife protection and conservation goals.

Midway is located in the North Pacific Ocean (near the northwestern end of the Hawaiian archipelago) -- approximately 1250 miles northwest of Honolulu -- about one-third of the way between Honolulu and Tokyo. At less than 150 miles east of the International Dateline, Midway Atoll is truly "midway" around the world from the Greenwich meridian. The atoll is an unincorporated territory of the United States and is the only atoll/island in the Hawaiian archipelago not part of the State of Hawaii. Midway Atoll National Wildlife Refuge is owned and administered by the USFWS on behalf of the American people and has international significance for both its historic and natural resources.

In 1988, Midway became a National Wildlife Refuge, at the time subject to the primary jurisdiction of the Navy. In 1993, the Navy decided to close the Naval Air Facility after more than 50 years of continuous operation. On May 20, 1996, custody and accountability for Midway Atoll transferred from the Department of the Navy to the Department of the Interior. President Clinton signed Executive Order 13022 on October 31, 1996, effectively superseding earlier orders assigning responsibility for Midway to the Navy. A new code of regulations governing activities at Midway Atoll National Wildlife Refuge was published in the Federal Register on March 10, 1998.

When Midway became a national wildlife refuge, it joined a network of more than 500 separate units of the National Wildlife Refuge System, encompassing nearly 93 million acres, throughout all 50 states and several territories and possessions. Refuges represent the only Federal lands set aside and managed principally for the conservation of fish and wildlife.

BSA UPDATES RADIO MERIT BADGE

The Boy Scouts of America (BSA) has updated the requirements needed to earn the Radio merit badge. The new requirements became effective with the publication of Boy Scout Requirements 2009. While no new content has been added to the program, the new merit badge pamphlet features lots of new information -- including color pictures and updated charts and text -- that reflects the changes in the Amateur Radio Service since the last pamphlet update in 2002. Approximately 4000 Radio merit badges are earned each year.

According to ARRL ad hoc Scouting Committee member Larry Wolfgang, WR1B, the new Radio Merit Badge pamphlet had been in the works for some time. "BSA has been replacing all merit badge pamphlets with new booklets using color graphics and more modern presentations," he said. "With attractive color photos and clear text explanations of the requirements, the new merit badge pamphlet is a pleasure for the Scouts to read. The new text is due in large part to the efforts of longtime Radio Merit Badge Counselor and K2BSA National Jamboree Staff member Mike Brown, WB2JWD. I am looking forward to using the new pamphlet to teach Radio merit badge at our Council's Merit-Badge-O-Ree this spring, and to having a supply of the new books available for Scouts during the 2009 summer camp season."

Wolfgang said that the requirements for the badge have been shifted around: "The old Part 4 of Requirement 7(b) Broadcast Radio was pulled out and placed in the main body of the requirements as Requirement 8. In addition, the old Requirement 8 (to visit a radio installation and discuss what types of equipment, how it was used, what types of licenses are required to operate and maintain the equipment, and the purpose of the station) was moved up to Requirement 7, so that now the three options appear as Requirement 9. The main result is one additional full requirement."

ARRL Rocky Mountain Division Director and Chairman of the League's ad hoc Scouting Committee Brian Mileshosky, N5ZGT, called the Radio Merit Badge "a perfect avenue to introduce Scouts and Scouters to the wonderful world of ham radio. Ham clubs across the nation should locate a local Boy Scout Troop, secure permission from their Scoutmaster and/or committee to teach the merit badge and deliver an exceptional Radio merit

badge class. What the boys -- and their leaders and parents -- will learn in the process is a fair amount of what is part of the Technician license exam, so the next logical step after a merit badge class is an all-out recruiting effort to get that Troop involved in Amateur Radio. They'll meet new friends and have a great way of communicating while in transit to and from the field, as well as additional peace of mind through an effective means of emergency communications while in the backcountry."
