Minutes Meeting of October 21, 2020

The meeting was held via ZOOM.

The treasurer's report was read by Art W2NAZ noting a balance effective September 30, 2020 of \$5,594.86. Next Denis K2NPT gave an update on dues. Expenses approved unanimously after motions by Marlo KA2IRQ and Dom N2DOM were \$206 for tower guywires to Denis K2NPT, \$75 to Art N2AJO for NJQP prizes, \$72 for clothing to Art W2NAZ and \$10 to Cy K2CYSfor website expenses.

Art N2AJO announced that John KA2F was chosen as Member of the Year 2020 by the officers and trustees. It was mentioned that a plaque would be awarded at an appropriate time and a luncheon would be held when health conditions would permit.

Under New Business it was approved unanimously after motions by Diane KD2NAD and Vince KE2V to expend up to \$250 for various awards by Denis K2NPT.

Paul AD7I made a motion which was seconded by Art W2NAZ and approved unanimously to award Phil Festa N2EDX lifetime GSARA membership. The words of this motion are attached to these minutes.

Art N2AJO proposed that GSARA make a donation of \$500 to "Fulfill" the local food bank. It was unanimously approved after motions by Cy K2CYS and Art N2AJO who would attach a cover letter to the donation-check.

The reading of the elections slate of nominations for club offices was made by Cy K2CYS who thanked his fellow election committee members, Blair KD2EPA and Alan W2NIR for their work: President Art Olson N2AJO; Vice-President Denis Commette K2NPT; Secretary John King KA2F; Treasurer Diana Noble KD2NAD; Chief Engineer Paul Newland AD7I. The nominations were then declared closed. Voting would take place at the November Business Meeting on November 18, 2020.
